

Privacy Policy

This document is used to inform website visitors regarding our policies with the collection, use, and disclosure of Personal Information for anyone who signed up for Linda Luchtman's newsletter or entered sponsored contents.

If you choose to sign up for Linda Luchtman's newsletter then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect are used for providing information and to update user/subscriber information only. We will not use or share your information with anyone except as described in this Privacy Policy.

Information Collection and Use

In order to receive newsletters, we may require you to provide us with certain personally identifiable information, including but not limited to your name and email address. The information that we collect will be used only to contact or identify you.

Log Data

We want to inform you that whenever you visit Linda Luchtman's website, we collect information your browser sends to us called Log Data. This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser version, pages of Linda Luchtman's website that you visit, the time and date of your visit, the time spent on those pages, and other statistics. This information may be used to create ads based on the information gathered. However, this data will not be shared.

Cookies

Cookies are files with small amounts of data that are commonly used as an anonymous unique identifier. These are sent to your browser from the website you visit and are stored on your computer's hard drive. In general, cookies are used to retain user preferences, store information for things like shopping carts, and provide anonymized tracking data to third party applications such as Google Analytics.
